Good afternoon **Eastern Pike County Regional Act 537 Plan Stakeholders Group**:

I wanted to let everyone know that all 4 municipalities have adopted the Plan as of this week! We have been coordinating with Patrick Devitt at DEP as things have been moving along so they are anticipating the Plan. Copies will be mailed to DEP next week – after we receive the transcripts from the last public meeting. We will copy the stakeholder municipalities on our submission to DEP.

DEP has 120-days to comment. Upon receipt of comments we will review and if needed, coordinate with the municipal partners for any major items. I'll keep the group updated on major milestones, like this one, but if you are interested in incremental progress updates because you have not heard anything in a while, please don't hesitate to give me a call, email or call the Westfall Authority as we provide updates in our monthly status reports to the Authority as the contractor facilitator selected by the group.

Dear Mr. Devitt:

On behalf of The Municipal Authority of the Township of Westfall, Westfall Township, Milford Township, Milford Borough, and Matamoras Borough, Herbert, Rowland & Grubic, Inc. (HRG) would like to inform the Pennsylvania Department of Environmental Protection (PADEP) that the municipalities, in accordance with Title 25 PA Code, Section 71.32 Paragraph C, considers the Eastern Pike County Regional Act 537 Plan to be approved by the PADEP.

Title 25 PA Code, Section 71.32:

*“(c) Upon the Department’s failure to act on a complete official plan or revision within 120 days of its submission, the official plan or official plan revision will be considered approved, unless the Department informs the municipality prior to the 120 days that additional time is necessary to complete its review. The additional time may not exceed 60 days.”*

The Final Plan was submitted and mailed to the PADEP on May 25, 2021, and received by the PADEP on June 1, 2021, according to the certified mail receipts from the United States Postal Service (attached). The 120<sup>th</sup> day after submission was on September 29<sup>th</sup>, 2021, and there has been no correspondence from the PADEP regarding a time extension request, comments, approval, or disapproval.

If the PADEP does not consider the plan to be approved, please **let us know by November 24, 2021.**





