As discussed last week, HRG has finished preparing the Revised Eastern Pike County Regional Act 537 Plan. The plan has been uploaded and saved at this link:

A detailed notes sheet that describes all of the revisions that have been made by chapter, section, and page number is included in the Box link. Due limited scope of changes and notes sheet provided, we are asking that all of the municipalities review the updates to the Act 537 Plan as part of an informal review in the next two weeks. If we could have all comments and questions by Thursday, August 18th, that would allow us to move forward with the next steps and send off to the Plan to the planning commissions, etc.

In addition, there has been some correspondence regarding the Act 537 Plan that was originally submitted in May of 2021. There will be a letter in the coming days or weeks about the “rejection of the original submission.” We have talked to the DEP, and there is no reason to be concerned. The “rejection” is only a formality that is part of an initiative from their Central office. They are aware that we are working through a Revised plan and our current status with it. Once we have gone through the planning agency review, regulatory agencies, public comment period, etc., we will submit the Plan to the DEP.

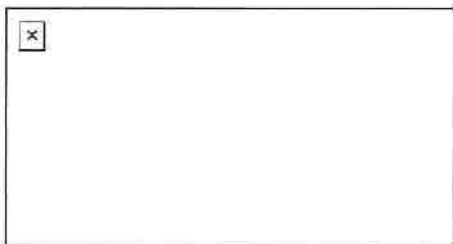
