Thursday October 20, 2022

Minutes

The October 20, 2022 meeting was held via in-person/Zoom in the Commissioners Meeting Room.

Present: K. Raser – Shohola Twp., J. Neufeld – Delaware Twp., S. Shamim – Milford Twp., M. Mrozinski, B. Snyder – Pike County Planning, C. Schmitt – Porter Twp., J. Gamboni – Rep. Peifer Office and T. Waldron of Pike County Commissioners.

CALL TO ORDER - The Pike County Council of Government was called to order at 3:00pm.

PUBLIC COMMENT REGARDING AGENDA ITEMS – None

ADOPTION OF THE October 20, 2022 AGENDA- Delaware Twp. made a motion to adopt the October 20, 2022 Agenda. Milford Twp. seconded the motion. **VOTE:** All in favor. **MOTION:** Approved

ACTION ON MINUTES – Shohola Twp. Made a motion to approve the minutes from the August 18, 2022 meeting. Delaware Twp. Seconded the motion. **VOTE:** All in favor. Porter Twp. abstained. **MOTION:** Approved.

TREASURER’S REPORT- Jane Neufeld reported that COG received \$0.16 in interest in the month of September. Also the account was charged a \$5 Dormant Account Fee. The total account balance is \$3,959.39. There were no new deposits or expenses. Keith Raser mentioned that in the past COG has sponsored classes for municipal officials and this could be a way to spend some money so the account is not charged that fee again. Porter Twp. made a **MOTION** to approve the Treasures report. Milford Twp. seconded the motion. **VOTE:** All in favor. **MOTION:** Approved.

NEW BUSINESS

COUNTY UPDATES:

1. Hazard Mitigation Plan - Brian Snyder stated the plan is has been approved by FEMA and he is currently working with the municipalities on having them adopt the plan. At the time of the meeting Brian stated that 5 municipalities have adopted the plan.
2. County Comprehensive Plan – Mike Mrozinski stated that the County chose Michael Baker to be the consultant for the project and they are currently gathering background information for the plan.
3. Household Hazardous Waste Event – Mike stated that the event will be on Saturday October 29th at the Dingman Delaware Middle School parking lot and there will be a small fee for the products that people bring. Paint will not be accepted at this event.

MUNICIPAL UPDATES –

October 20, 2021

1. Delaware Twp. – Jane Neufeld shared that the township hired a new roadmaster and that there is a new Superintendent at the Delaware Water Gap.
2. Shohola Twp. – Keith shared that Advanced Recycling will be opening up in Shohola Township at the old lumber yard in the town of Shohola. The township just needs to approve a few permits.
