2022 4th Quarter Milford Fire Department **EMS Report**

First and foremost, Milford Fire Department would like to thank the Milford Township Supervisors and residence for their continued and dedicated support and that Milford Fire Department can only be the great department it is today with the continued support and dedication the residence gives us. Milford Fire Department Ambulance in 2022 answering a total of 619 emergency 911 calls with over 300 hours of volunteer time by the members of Milford Fire Department. Going into 2023 Milford Fire Department anticipates another busy year answering 911 emergencies throughout Pike County and continues to work on recruiting and retaining members for EMS while still trying to obtain 24/7 ambulance coverage in 2023 and in years to come. Milford Fire Department hopes for an even better 2023 than 2022 and will be putting additional efforts into recruiting volunteers for EMS and will be looking to hold 3 EMS trainings by end of first quarter of 2023. Milford Fire Department is still looking at an estimated \$250,000.00 to be able to fund and cover the cost for 24/7 EMS coverage. The \$250,000.00 needed is the amount estimated needed to cover the additional 12 hours per day for 7 days a week that are not currently covered due to lack of funding and monies to pay for those services. The tables below are the final numbers for EMS for the year of 2022. Thank You again and we look forward to another great year.
